# IDECO Establishment and Development

- IDECO was established in 1957 and was trading as Irbid National Electricity Company In 1961 .
- IDECO was granted the exclusive right to generate, transmit, distribute, and supply electricity in the northern region of Jordan, which includes Irbid, Jarash, Ajloun and Mafraq districts.
- IDECO has increased its coverage area since 1961. In 2023 IDECO covered (326) cities and villages, (1291) residential complex. IDECO also was able to increase its capital from (285) thousand JD in 1962 to (14) million JD.
- By issuing the general law of electricity and establishing the Jordan Electricity Authority, IDECO's activities were limited to transmit and distribute electrical energy in its region.
